\$10 Surcharge to be Imposed Next Billing Cycle

It's no understatement to say that **we failed to properly anticipate the inflation surge**. After reviewing the budget, considering the revenue from the rate increase, we realized we will still be under budget by approx. \$28,000 for the current fiscal year. July 1, 2022 thru June 30th 2023.

Beginning next bill cycle, March 2023, your bill will include a new fixed charge of \$10.00 – Surcharge. This fee will help reduce the size of the budget deficit.

Accurate funding is beyond necessary - It's essential to ensure so that we can provide safe and reliable services to our residents.

As prices for everything continues to rise, it's important to remember that LLCSD is not excluded from this. We are seeing the same price increases in our bills that you're seeing at home.

We understand the hardship this may put on some and we want to reassure you that we are considering all options possible. Such as, staff members are also reducing their hour to offset the expenses to the district has. To sum it up, there will be a \$10.00 surcharge starting with your next month billing cycle - March and it is to accelerate the recovery of our financial status due to continued inflation. This should only be for approx 6 month



Wrapping 2022 Up!

The graph shows the amount of consumption in gallons the district used over the course of the year in comparison to the previous year.

The districts 2022 usage slashed the 2021 water usage by 2 million gallons, a significant cutback -which results in a total decrease of 10% in usage for the year 2022.


