## DUMPSTERS TO BE DEIVERED IN MAY

This is an opportunity for you to clean up any weeds, yard waste or debris in your yards.

After dumpster day, code enforcement will drive around and see if there are still homes that are overgrown, or have debris laying around. They

will also be looking for vehicles in the front yards that are NOT registered or on a non-op. They will then send letters out advising you that you must clean them up or a fine could be issued. More dumpsters will again be placed in the community to give you

a second chance. Code enforcement will then drive around to see who complied. For those who don't-you may be paying a hefty fine.

## TOWN HALL MEETING YIELDS GREAT INFORMATION

Most Leavitt Lake residents did not attend the town hall meeting. However, it was very informational and below you will find some highlights of the meeting.

### **\*\*\*From the Sheriff's Department**

We have had an on-going problem with dogs running the neighborhood. As most of you know, we no longer have an "animal control" officer at the animal shelter. The Sheriff's department is now handling these types of calls. From what we understand, the Sheriff's department has two designated positions for animal calls.

### **\*\*\*Neighborhood Watch**

The neighborhood watch program is underway here in Leavitt Lake. Amanda Smith has volunteered to organize it. She will be contacting people soon. If you are interested in being a member, call the office and we will take your information. The signs have been ordered.

### **\*\*\*Real ID/National ID**

If you do not currently have a passport, you will need to get what is called a "Real ID" or "National ID". If you do not have a passport or "Real ID" you *will not be allowed* to fly anywhere. You must also have this to gain entrance on any military base or federal building. Children must also have this "Real ID".

Driver's licenses and IDs must now also include a common barcode and security devices to prevent any tampering with or counterfeiting of the card, and must display a star in the upper right-hand corner, signifying that your identification has been approved by the TSA and your identity has been verified. There are also new requirements put in place to obtain an ID or license; all applicants must present the following documents during the application process:

- A photo ID, or non-photo ID that contains the applicant's full legal name and birth date
- Valid birth certificate
- Social Security number

Proof of legal U.S. citizenship, OR proof of lawful admittance into or temporary residence within the U.S.
