A. Engagement Letter Between LLCSD and Zach Pehling, PnP CPA

B. Bid Submission for Electrical Work – Park Grant

Monath Construction presented to the board Change Order # CO-2255-1 in the amount of \$46,094.97. Lance explained with in this change order he will subcontract some of the work to Nova Electric. Nova is to complete the installation of the new light poles with new figure heads and swap out the existing 10 light fixture heads throughout the park. Lance explained that the additional \$46,094.97 includes the cost of Nova Electric, any equipment, material, and all necessary labor to complete the scope of work described within the change order. It was moved by Dallas Langley and seconded by Carrie Base to approve Change Order #CO-2255-1 in the amount of \$46,094.97 to Lance Monath for project # 18-18-009 Park Grant. Motion carried unanimously.

A. District Financial Report


Teo Lovin gave the District's Financial Report for September 2023. Teo explained the reports included consist of the Districts Cash Management Report, Accounts Payables and the Profit and Loss Budget VS Actual report of the fiscal year to date. 
