2023/2024 Statement of Economic Interest form 700

Adrianne Giles explained to the board that every elected official and public employee who makes or influences governmental decisions is required to submit a Statement of Economic Interest, also known as the Form 700. The Form 700 provides transparency and ensures accountability in two ways: first, It provides necessary information to the public about an official's personal financial interests to ensure that officials are making decisions in the best interest of the public and not enhancing their personal finances. Second, It serves as a reminder to the public official of potential conflicts of interest so the official can abstain from making or participating in governmental decisions that are deemed conflicts of interest. Forms were given to each board member signed and returned.

Workplace Bulling and Violence Policy

Adrianne Giles presented to the board the **Workplace Bulling and Violence Policy.** California's Governor Newsom recently signed <u>SB 553</u>, requiring the California Division of Occupational Safety and Health to adopt a general industry workplace violence regulation by December 31, 2026. In the meantime, all California employers with one or more employees (working in any state) <u>must</u> implement a workplace violence prevention plan ("WVPP") plan by July 1, 2024 It was moved by Dallas Langley and seconded to approve Workplace Bull Policy. Motion carried unanimously.
